The primary purpose of the Minor Adjustments Transitional House and Discipleship Program is to help individuals coming from incarceration or rehabilitation facilities to make a smooth transition back into their communities.

## **B. Goals and Objectives**

We operate as a self-managed, self-sustained residence that is free from drugs and alcohol. Our goal at Minor Adjustments Transitional Housing is to support individuals in maintaining their recovery by providing a safe and supportive environment. We understand that returning to old environments where drug use and criminal activities were prevalent can be stressful and triggering for some individuals. Therefore, our program aims to create a family-like atmosphere where house guests can learn essential life skills, motivation, productive living, spirituality, success, and coping skills. Our focus is on fostering personal growth and well-being in a secure environment.

## **C. Keys to Success**

In order to achieve success, our primary objective is to acquire funding from various sources such as family members, sponsors, investors, and grants. Additionally, we aim to secure suitable housing through ownership, rental, leasing, or receiving it as a gift, with the intention of remodeling and furnishing it accordingly. Another crucial step involves developing an operating budget and establishing house guest managers to oversee the operations.

# Company Summary

## A. Company Background

Minor Adjustments Transitional House will be in every county wherever possible. The program was created by Michael and Lernel Williams. Who also runs the Minor Adjustments Program which is an 8-week course that they teach in different facilities, after being successful in helping people in that area they decided to start branching out to help people in another area which is helping them gain some foundation after rehabilitation.

However, our transitional house guests understand the importance of actively participating in a Recovery Support group or engaging with a Church to ensure sustained sobriety. We provide a unique opportunity for individuals in recovery to live together as a cohesive family unit, with a shared focus on transforming their individual lifestyles to be free from alcohol, drug use, and criminal activities. One of the challenges faced by individuals struggling with addiction or strongholds is the lack of structure. We firmly believe in the concept of the family as the foundation, with the vision of the family driving our approach. As a result, our houses are thoughtfully structured and designed to function as a single-family or discipleship household.

## B. Resources, Facilities, and Equipment

Minor Adjustments Transitional House will be equipped with everything that will make life comfortable for the house guest transitioning back into their daily lives after rehabilitation. They will be fully furnished, and offer the following things: WiFi Internet, Basic Cable Television, or internet-based television, Land-line telephone access, appliances (including coffee maker, computer, and microwave), coffee, cream, sugar, toilet paper, paper towels, hand soap, dish soap, all cookware, dishes, and silverware, trash bags, all household utilities, and various cleaning supplies.

## D. Ownership Structure

Each individual Minor Adjustments Transitional House and Discipleship Program is given a number after it (i.e. House 1, House 2, etc.) which makes it a part of the network of Minor Adjustments Group, Inc. houses. The organization maintains the sole responsibilities over the individual houses exercising authority over the upkeep, maintenance, policies and monitors the activities of each house. It is in this manner that Minor Adjustments Group, Inc. remains responsive to the needs of the population it serves.

## **Products and/or Services**

We explain the purpose of the Minor Adjustments Transitional House and Discipleship Program which is to provide a safe Drug & Alcohol-free place to live where they can pursue their recovery. We review our guidelines, rules, and regulations for maintaining a sober living environment. If necessary, we offer transportation to their initial Twelve-Step meeting, Church Services, Minor Adjustments meeting, or other community support gatherings. We emphasize the significance of finding a sponsor or mentor within the church who can guide them through the recovery process expeditiously. In their initial week, we accompany them to nearby non-profit organizations where they can obtain donated food and clothing (sometimes a bicycle). Then if needed we begin the process to get I.D., Birth certificates, Social Security cards, etc.

# **Market Assessment**

## **A. Examining the General Market**

Minor Adjustments Transitional House and Discipleship Program was established to service those needing help transitioning back into society in New Jersey and other cities around the world.

In general, those who need the services of transitional/discipleship houses are the incarcerated or rehabilitated population and perhaps those who need daily help.

Despite welcoming a diverse range of house guests, we remain committed to adhering to the regulations and guidelines that govern the transitional/discipleship housing industry in the United States. Our house guest managers will receive comprehensive training to ensure the smooth operation of our houses in a warm and familial environment.

## **B. Strength**

Our strength emanates from our unwavering Faith in God, which guides and inspires us in all aspects of our organization. As a matter of fact, they are some of the best hands to handle the type of family members we will be dealing with owing to their own personal experience in the field. The Minor Adjustments Transitional House offers a unique operational approach to individuals facing substance use disorders or a criminal lifestyle. It provides a realistic opportunity for these individuals to establish a strong foundation in sobriety, ensuring long-term abstinence. The primary focus of the Minor Adjustments Transitional House is to facilitate a smooth transition back into the community for individuals coming from Drug Rehabilitation facilities.

Ever since the first Minor Adjustments Transitional House started the men and women in Minor Adjustments Transitional House have made all that they do – or fail to do – open to the public. As a 501(c) (3) nonprofit organization, Minor Adjustments Transitional House keeps its finances, actions, and locations open to the public because we want the public and neighbors to know what we do and why we do it. Feel free to stop by and visit the men or women living in a Minor Adjustments Transitional House.

All our materials are included on our website and neighbors can understand how Minor Adjustments Transitional House works. This assumes significance for reasons: [1] we want neighbors to know us, and [2] neighbors want to know us because they usually know someone or have a relative that has been affected by substance use disorder and or criminal lifestyle.

The Minor Adjustments Transitional House brings a sense of positivity and hope through its discipline-based concept. By implementing a structured system of operations, it aims to replace feelings of hopelessness with hope and transform past failures into future successes. Moreover, the Minor Adjustments Transitional House concept of self-support saves taxpayers a lot of money and it produces successful recovery without relapse for four to five times as many individuals as any other recovery method afforded to those with substance use disorders. ## **Minor Adjustments Transitional House Policies, Rules, and Regulations**

The undersigned acknowledges and understands she/he is living in an alcohol and drug-free shared-living situation, operated by the Minor Adjustments Group, Inc. The undersigned is a House Guest in the capacity of a Minor Adjustments Transitional House sharing a living unit and not as a tenant. No possessory right is granted or intended by this agreement.

In the event. The undersigned fails to abide by the policies and rules of the Minor Adjustments Transitional House. The undersigned agrees to vacate the premises and to do so without the requirement of legal processes.

- 1) Zero Tolerance for drug or alcohol use. (No engaging in illegal substance manufacturing, possession, and/or distribution will be tolerated.), House Guests must be willing to submit to a drug/alcohol urine screen and or breathalyzers upon the request of the directors or House Guest manager. Anyone who refused a test and those who tested positive are ask to leave, we will assist them in getting into an inpatient program, However, they would still be required to leave.
- 2) Zero Tolerance for physical confrontation or verbal confrontation with any House Guest.
- 3) Zero Tolerance for sexual activity between House Guests of the same or opposite sex.
- 4) All House Guests are expected to dress accordingly.
- 5) Each House Guest will be provided a set of linens (mattress cover, sheets, pillow, etc.).
- 6) No use of any tobacco products inside the house, there is smoking outside at all homes, please dispose of cigarette butts in the proper containers provided. There is absolutely no loitering in the front of the property.
- 7) Zero Tolerance for stealing or BORROWING MONEY (Taking food from others without permission is considered stealing. We encourage community cooking, meal planning, and sharing dinner time together. This is to assist in developing a family-like structure.)
- 8) No “contracts” or “stashes”. Contracts are agreements between two or more individuals to cover up negative behavior.
- 9) The curfew is at 10 PM unless your referral source sets a different time for you. All visitors to the property must be approved by a House Guest manager and must be off the property by 9:00 PM. Visiting is only in a common area, and not only in bedrooms.
- 10) Any visitor to the property will be asked to leave immediately if Minor Adjustments Transitional House Guest Manager suspect any use of illegal or illicit drugs, including alcohol. House Guest who has been asked to leave due to their own breach of rules will not be permitted back on the property.
- 11) Overnight passes are given after 60 days of living at Minor Adjustments Transitional House (Maximum 2 nights per week) and must have prior approval from the director or House Guest manager. However, your weekly donations do not change.
- 12) Residents at the Minor Adjustments Transitional House have 30 days to find a job or enroll in school while actively participating in their recovery program. Even if they are attending school, they still need to contribute with weekly donations as part of their commitment to the program.
- 13) House Guest rooms must be clean at all times. (House Guest beds are to be made when the House Guests are not in bed.) Everyone is responsible to clean after themselves and in the kitchen 24 hours a day, 7 days a week. NO EXCEPTIONS!!!

- 14) House Guest must attend **a)** Mandatory 8-week Minor Adjustments Program (One group per week). **b)** All residents must attend some kind of recovery or community support meetings weekly (i.e., Victorious Living, AA/NA meetings, Celebrate Recovery, Church, etc.)
- 15) Personal radios & the house TV can be used but must stay at a volume that is always considered by another House Guest.
- 16) We request that a House Guest commits to a 90-day stay. Concerns and/or complaints are to be brought to the weekly house meeting to be discussed. House Guest input is encouraged and is necessary for a healthy living environment.
- 17) All Minor Adjustments Transitional Houses are either male or female not mixed.
- 18) Loud and abusive language is not allowed in homes. No pornography movies.
- 19) Once a month, all residents of the Minor Adjustments Transitional House are expected to attend a Spiritual Meeting. These gatherings welcomes and encourages the participation of friends, family, loved ones, and members of the recovery community. The ultimate goal is to foster a sense of family within the house, with the belief that the family is the central focus. The intention is to enable House Guests to rebuild and restore the concept of family life during their stay at the house.
- 20) Any House Guest who is on prescribed medications, must immediately inform the House Guest manager; all medication must be approved by the resident manager. All medications must be taken as prescribed. Prescription narcotic medications are not permitted at Minor Adjustments Transitional House. Medications are not to be shared with any other House Guest.
- 21) All House Guests are required to have a sponsor, mentor, or role model that supports them in their recovery.
- 22) PETS – ARE NOT ALLOWED.
- 23) NO WEAPONS ON PREMISES
- 24) As a member of a recovering community, based on the principles of honesty, trust, and helping to create a safe and sober environment, we request any House Guest who knows that another House Guest has violated any rules of Minor Adjustments Transitional House report the behavior to a House Guest manager and they will handle it without your name being mentioned.
- 25) Each family member is required to make a weekly donation of \$130 which is due every Friday. The donations are used to help maintain the house and also help with opening other new houses to assist families in overcoming adversities to rebuilding their lives.
- 26) All Minor Adjustments Transitional Houses are fully furnished, and offer the following things: WiFi Internet, Basic cable television or internet-based television, Land-line telephone access, appliances (including coffee maker, computer and microwave), coffee, cream, sugar, toilet paper, paper towels, hand soap, dish soap, all cookware, dishes, and silverware, trash bags, all household utilities, and various cleaning supplies.
- 27) Minor Adjustments Transitional House reserves the right to make changes, exceptions, and add anything that will benefit our program and our House Guests' best interests at any time for any reason.

Congratulations! Your application for exemption from New Jersey sales and use tax has been approved. An Exempt Organization Certificate (Form ST-5) is enclosed. Minor Adjustments Transitional House primary purpose is to help individuals who are coming from Drug Rehabilitation facilities or incarceration to make a smooth transition back into their communities.

While the house and its residents do not provide any treatment, recovery, or detoxification services, members of the house are able to provide support for one another through daily conversations and house organized meetings and mandatory morning devotionals that promote sobriety and recovery.

## PAYMENTS:

Each family member is required to make a weekly donation of \$130 which is due every Friday. The donations are used to help maintain the house and also help with opening other new houses to assist families in overcoming adversities to rebuilding their lives.

## APPLICATION PROCESS:

Call our office 1.888.233.3299 to schedule an interview in person, Zoom, or via phone. Also, you can apply for residence on our website. The purpose of the interview is to determine whether you are acceptable and appropriate for the service we offer.



## Requirements (Mandatory)

- \* Attend Minor Adjustments Program (1x a Week).
- \* All residents must attend Recovery/Community support meetings
- \* Submit to random Drug/Alcohol testing.
- \* Be considerate and respectful to other residents.
- \* Do daily chore and Keep personal area clean.
- \* Attend house meetings, Abide by curfew
- \* Make a commitment to stay clean and sober.
- \* We request that a resident commits to atleast a 90-day stay.
